FACTS AND CLAIMS OF THE PARTIES

The plaintiff claims against the defendant for infringement of European patent 3 221 117.

On 22 January 2024, an interim hearing was held before the judge-rapporteur via video conference.

Mojca Mlakar and Beate Schenk also took part in this hearing on behalf of the adjudicatory body. Order

- 1. The written procedure ends on 8 March 2024.
- 2. The date for the oral hearing on 16 April 2024, 9.00 a.m., is confirmed.
- 3. The duplicate period for the defendant ends on 9 February 2024.
- 4. The plaintiff has until 23 February 2024 to respond to this in writing.
- 5. The defendant has until 8 March 2024 to respond to this in writing.
- 6. The deadline for the defendant to respond to the request for referral pursuant to Rule 190 of the Rules of Procedure (App_882/2024) ends on 9 February 2024. A decision will then be made on how to proceed.
- 7. The parties are requested to submit a preliminary estimate of the costs by 8 March 2024 at the latest (Rule 104.k VerfO).
- 8. The amount in dispute is set at € 2 million.
