BRIEF DESCRIPTION OF THE FACTS OF THE CASE AND THE PARTIES' APPLICATIONS

1. On 1 June 2023, 10x filed an infringement action against Vizgen of the Unified Patent Court with the local division Hamburg of the Court of First Instance
2. Vizgen filed three applications under R. 190.1 of the Rules of Procedure of the UPC Agreement (hereinafter: RoP), seeking an Order for the production of certain documents by 10x
3. With the contested orders, the Court of First Instance (partially) granted applications for referral. the three
4. 10x has lodged an appeal against the contested Orders (APL_59634/2024 UPC_CoA_654/2024, APL_61301/2024 UPC_CoA_700/2024, and APL_26/2025 UPC_CoA_1/2025, hereinafter: the appeals).
5. In documents dated 10 February 2025, 10x requested the withdrawal of the appeals (App_6377/2025, App_6378/2025, and App_6376/2025). 10x does not request a decision on the costs of the parties.
6. Vizgen agrees appeals. to the withdrawal of the Vizgen also does not apply for costs.

REASONS FOR THE ORDER

7. Pursuant to R.265 RoP, a plaintiff may as long as no final decision on an action. request the withdrawal of his action has been made This provision applies (mutatis mutandis) also to an appellant who requests the withdrawal of his appeal (UPC_CoA_234/2024 APL_27805/2024 App_38102/2024, 10x - Curio).
8. The Court of Appeal allows the withdrawal of the appeals on the application of 10x and with the consent of Curio.
9. R.265.2(c) RoP provides that a decision on costs is to . be in accordance with Part 1 Chapter 5 However, as both parties have waived a decision on costs, no decision on costs is required here.

ORDER

The Court of Appeal

- I. allows ;the withdrawal of the appeals
- II. declares the appeal proceedings closed;

III. Orders that the Order be entered in the register
