SUBJECT MATTER

Application pursuant to rule 353 RoP.

SUMMARY OF FACTS

On 28.10.2025 Applicants requested that the Court rectify pursuant to rule 353 RoP the Decision issued on 27.10.2025, indicating that Defendant 1 and Defendants 2 are both also represented by Paolo Creta, Elisa Viotto and Francesco Ricotta (of Studio Legale Costa-Creta, Piazza

di Porta Ravegnana n. 1, Bologna, Italy), as well as by Cristina Schiavone e Federico Manzella (of Manzella & Associati, via dell'Indipendenza 13, 40121 Bologna, Italy).

On 3.11.2025 the Respondent submitted its comment, indicating that it had no objections regarding the request.

GROUNDINGS FOR THE ORDER

The request for rectification is admissible as it was submitted within one month of service of the decision to be rectified, pursuant to rule 353 RoP.

The issue that needs to be rectified is a simple inaccuracy that requires correction.
