SUBJECT OF THE PROCEEDINGS: Patent infringement action – enforcement proceedings, withdrawal.

BRIEF SUMMARY OF THE FACTS:

Claimant withdrew its request, dated 23 July 2026, for the imposition of penalty payments on Defendants by brief of 6 August 2026.

Defendants did not submit a comment on the requested withdrawal.

REASONS FOR THE DECISION

If R. 265 RoP is to be applied, by way of analogy, to a withdrawal of a request for the imposition of penalty payments according to R. 354.4 RoP, the withdrawal at hand is hereby permitted. Defendants have raised no objections. Further, no interests on the part of Defendants are apparent that would preclude a withdrawal in favour of a decision on the merits of Claimant's penalty request.

Consequently, and in the absence of any indications to the contrary, Claimant shall bear the costs of the enforcement proceedings.

DECISION:

1. The withdrawal of the request, dated 23 July 2026, for the imposition of penalty payments on Defendants is permitted.
2. The enforcement proceedings are declared closed.
3. This decision shall be entered on the register.
4. Claimant shall bear the costs of the enforcement proceedings.
